Terms & Conditions

A. OUR RESPONSIBILITIES

1. Campsites: we do not allocate camp sites - you choose where you camp.
2. Water: All potable water supplied to camping sites has passed through a Puretec Hybrid G250 3 stage water filtration system.
3. Toilets & Showers: we will clean these each day.
4. Fire pits & Firewood: We have located fire pits at safe suitable positions and will sell you dry firewood for use in the pits only.
5. Fire Evacuation Point: is signposted in front to the shed on the driveway.
6. Gas BBQs: we will supply the gas for the BBQs inside the undercover patio together with the Fire Blankets and picnic tables.
7. Rubbish Disposal: we have provided 3 types of rubbish bins for disposal of general waste, glass and cans.
8. Swim Pond: we have constructed a swim pond for guests to use. The water in the pond is tank collected rain water.
9. Pet Friendly: All pets must be kept on leads at all times.



B. YOUR RESPONSIBILITIES

1. Campsites: Look up before you choose your camp site.
2. Fire Pits: must not be moved and fires must be limited to knee height. You must attend the fire at all times and make sure it is extinguished before you go to bed. Do not burn rubbish in the fire pits - dispose of rubbish in the bins.
3. Chainsaws: No chainsaws allowed to be used on the property at any time.
4. Children: Your children must be supervised at all times in the park.
5. Swim Pond: Your children must be supervised at all times in the swim pond. No diving in the pond and no floating devices.
6. Swim pond will be open from 7.30am and closed at 9:00pm each night.
7. No Smoking in or around Tents / Swim Pond or Patio areas.
8. No glass in or around the swim pond and no excessive drinking in the pond area.
9. If a guest breaks a glass in the pond he/she agrees to pay the cost for draining the pond, supplying new sand, labour, machine hire and refilling the pond (Tank Water) - Cost for the above - \$24,000.00
10. Risks: You accept the natural hazards including but not limited to; uneven ground, tree roots, logs, falling tree limbs, snakes and wildlife and getting bogged in soft ground.
11. No excessive noise after 9:00pm. Please respect other campers.
12. Pets: You must clean up after your pet and no pets are permitted inside the bell tents. NO DOGS/PETS IN POND AREA.
13. Generators can be used for a short time during the day to charge batteries and must be off by 6:00pm
14. Be careful of wildlife in the property. Do not feed them and do not harm them.
15. The road is a shared zone maximum speed is 10KMH.
Be mindful of families with children.
16. Showers: Be careful when using the toilets and showers as the surfaces might be slippery.
17. BBQ's - You must clean the BBQ after use.
18. Repair / replacement costs for damage to any items or property will be charged to the camper responsible for such damage.
